
February MAC Meetings Were a Success

Wake Electric Awards RoundUp Grants to Area Nonprofits



Wake Electric awarded more than \$5,000 in grant monies during the 4th quarter of 2010 to

deserving nonprofit organizations located in counties served by the co-op. These grants were made available through the Operation RoundUp program.

Nonprofit agencies located in counties that Wake Electric serves, which include Durham, Franklin, Granville, Johnston, Nash, Wake and Vance counties, are eligible to apply. The agency does not have to be a member of Wake Electric.

Grants are open to all projects and subject areas that enhance economic infrastructure and job creation, promote service or charitable organizations, and meet emergency needs of individuals within the Wake Electric service area.

The next deadline for Operation RoundUp grant applications is June 10, 2011. A simple and convenient downloadable application can be found at www.wemc.com.

Since Operation RoundUp began in 1996, the program has awarded more than \$300,000 to area nonprofits.

Wake Electric's Bright Ideas Education Grant Program Kicks Off 18th Year of Giving

TEACHERS CAN APPLY NOW FOR 2011-12 BRIGHT IDEAS EDUCATION GRANTS



Wake Electric has earmarked \$50,000 for classroom-based projects through the Bright Ideas education grant program for the 2011-2012 school year. Teachers may begin applying on April 1 for grants up to \$3,000. To learn more about the program or to start an online application, visit www.ncbrightideas.com.

The Bright Ideas grant program, the only one of its kind in our state, is exclusively for North Carolina's K-12 teachers. The deadline to submit applications for the 2011-2012 school year is Monday, September 12. Teachers who submit their application by the early-bird

deadline on Monday, August 15, will be entered in a drawing to win a \$500 Visa gift card.

"Wake Electric is proud to continue promoting creativity in North Carolina classrooms and award these grants to deserving teachers," said Fred Keller, Manager of Member & Energy Services. "Last year, the cooperatives were able to collectively benefit more than 100,000 students through the program statewide."

Bright Ideas has funded a wide variety of classroom projects in all disciplines that would otherwise cost teachers money from their own pockets or go unfunded. Since its inception in 1994, the Bright Ideas program has awarded more than \$7.3 million in grant money and funded more than 7,000 projects. Wake Electric's Bright Ideas grant program alone has awarded more than \$530,000 to area educators since 1994.

"We have the utmost respect for teachers in our state and look forward to continuing to do our part to improve their jobs and the quality of education in North Carolina through the Bright Ideas program," said Keller.

Classroom Technology Awards Program Kick-Off

Wake Electric seeks applicants for its Classroom Technology Awards grant program. The co-op will award grants to North Carolina teachers serving both grades K-12 and area community colleges. The grants, to be used during the 2011-2012 school year, will be awarded in any discipline or subject for specific technology such as computers, digital cameras and software. The technology must benefit the students in the classroom.

Public school and community college teachers in Durham, Franklin, Granville, Johnston, Nash, Vance and Wake counties are eligible to apply. The final deadline to submit all grant applications is Monday, September 12. Teachers can apply for grants up to \$3,000. Only online applications will be accepted.

Poles aren't for Posting!



April is the time of year for spring cleaning and yard sales. You might be tempted to post yard sale signs on utility poles in your neighborhood. This seemingly innocent strategy creates serious safety hazards.

Staples, nails and tacks used to hang signs, as well as the signs themselves, pose dangers to your electric cooperative's line workers. These workers climb poles to restore power following storms or to perform routine maintenance to ensure system reliability. Objects such as birdhouses, balloons, flags and posters can interfere with accessibility and nails and tacks can snag utility workers' boots or

puncture safety clothing and other protective equipment. A hole in protective clothing puts line workers at risk for electrocution.

Furthermore, tampering with utility poles is illegal and can result in costly fines. According to North Carolina law, this misdemeanor could lead to a fine, community service or jail time.

So, instead, consider stand-up yard signs that can easily be placed in your yard and neighborhood. Also consider posting flyers on bulletin boards or leaving flyers with local retailers. Your electric cooperative appreciates your help in keeping utility poles clear and line workers safe.
